### A MESSAGE FROM CHIEF AND COUNCIL

#### Au Siem Leey'qsun Mustimuhw,

The Leadership continues to be energized by the signing of our Incremental Treaty Agreement (ITA) with BC and Cowichan Tribes. Acquiring the land is the first step in the re-establishment of our Leey'qsun Village site on Vancouver Island!

This Village site has been a long-fought effort for our People. The past work of Leey'qsun Leaders, going back to the first Land Commission hearings, nearly a hundred years ago, is evidence of our Leadership fighting for the return of our Land to our People. **We raise our hands to all our Leaders who have gone before us for this work.** We thank all former Council members for their dedication to this work. We especially raise our hands to Grand Chief Pahalicktun, Richard Thomas, for his unrelenting dedication over 31 years to secure land for the Leey'qsun Mustimuhw.

We have prepared this special edition newsletter to share important information about the historic day of signing, May 11, 2024. This newsletter is focused on the ITA: a map of the new lands; images from the signing; snapshots of the ITA and the Memorandum of Understanding (MOU) between Lyackson First Nation and Cowichan Tribes. We hope you find this information useful. Acting on the agreement, we have established a Joint Holding Corporation with Cowichan Tribes to hold the new lands.

The two Nations are working together to determine how the new lands will be divided into two equal parcels, as well as identify an evergreen space between the parcels, with equal contributions from each Nation. The MOU commits to the establishment of a Working Group, which will make a recommendation to the Leadership on how the parcel should be divided.

The fundamental principles guiding the joint Working Group are:

i. Snuw'uy'ulth: Hul'q'umi'num laws and teachingsii. Ts'ets'uw-wutul: helping each other

iii. **'Uy shaqwalawun:** good thoughts, manners, and/or behaviour

iv. **Mukw ihwet'uw ts' qwul:** everybody has a voice

The Addition to Reserve application phase of the work will begin once the division of the new lands is completed.

After reading the enclosed newsletter, we hope you will share in our enthusiasm for our future and future generations of Leey'qsun Mustimuhw.

# PROVINCE TRANSFERS LAND TO LYACKSON FIRST NATION

Thanks in large part to the persistent efforts of Lyackson Chief Pahalicktun, **the Province transferred 312 hectares of land** near Skutz Falls Provincial Park to Lyackson First Nation and Cowichan Tribes, creating **an accessible space Lyackson community members** can call home for the first time in decades.

The parties **signed the official agreement** at a ceremony at Skutz Falls on **May 11, 2024**. Signatories included Lyackson Chief Pahalicktun, Cowichan Tribes Chief Sulsulxumaat, Premier David Eby, Lyackson's Laxele'wuts'aat, Minister of Indigenous Relations and Reconciliation Murray Rankin, and Sunaxwumaat of Cowichan Tribes.

The event included singing, dancing, and the exchange of gifts including blankets, paddles, cedar boxes, and more. An estimated 150 people attended.





The land transfer is part of an Incremental **Treaty Agreement between B.C., Lyackson First Nation, and Cowichan Tribes.** To make the transfer possible, the Province purchased the land – which was previously privatelyowned and is worth an estimated **\$8.55 million** – from Mosaic Forest Management.

# THE WORK OF GENERATIONS BEARS FRUIT THROUGH LAND BACK

Lyackson and Cowichan will **hold the land together** under an Inter-Community Memorandum of Understanding for the time being. Ultimately, Lyackson will work with Cowichan to **divide the land into two equal parts** – one for each community – and will maintain a portion of each parcel as green space for future generations to enjoy.

The transfer was made possible by the work of four generations of Lyackson First Nation **members**, carried forward tirelessly by Chief Pahalicktun, and is a small step towards remedying the total displacement of the community caused by colonization.

While Lyackson traditionally had a winter village at the mouth of the Cowichan River, Lyackson's post-colonization reserve lands were limited to Valdes Island, which is difficult to access and lacks basic infrastructure. The newly transferred land is much more apt to house a community.

In the coming years, Lyackson will **develop the land to meet the needs of members**. It will become a place to gather, share culture and language, access services, and, ultimately, to call home. The land will also house a cemetery, ensuring members are no longer buried on the lands of other communities.
